# Information of the Administrative Support Centre for Projects of 4 March 2021



on: submitting applications in the call for proposals of the National Center for Research and Development under the competition 1 / 1.1.1 / 2021 - Fast track.

We would like to kindly inform you that the National Center for Research and Development (NCBiR) has announced a call for proposals financed under the **competition 1 / 1.1.1 / 2021 - Fast track**, covering industrial research and / or experimental development works (possibly supplemented with preimplementation works), which result is the development of an innovative solution that can be implemented in business.

Centrum Administracyjnego Wsparcia Projektów

The call for proposals at the NCBiR lasts from 22 March to 4 May 2021, until 4 p.m.

The call for proposal is divided into two rounds:

- from March 22 to April 12, 2021 at the latest. (1st round)
- from 13 April to a maximum of 4 May 2021 until 4:00 p.m. (second round)

The call for proposals in a given round of the competition will be closed when the sum of the value of co-financing in the submitted applications in a given round exceeds 500% of the allocation for the given round.

The planned funds for co-financing the projects are as follows:

- in the first round: PLN 100,000,000
- in the second round: PLN 200,000,000

#### Please read the information related to the preparation of the application:

- The call is open to companies and research units registered and operating in Poland, which are members of the consortium, but the consortium must include at least one enterprise and at least one research unit.
- Only an enterprise can be a consortium leader. A consortium may consist
  of up to three entities.
- Each consortium participates in the implementation of industrial research or experimental development works.
- The condition for receiving a grant is the implementation of the results of industrial research and experimental development works within three years from the completion of the project.
- According to the rules of the competition, the project may be implemented only in less developed regions, which, according to the definition contained in the competition regulations, include all provinces except Masovian District (more developed region).
- The project co-financed in the call must be part of at least one National Smart Specialization (KIS) - the list of KIS can be found on the call website in the "Documents" tab - www.gov.pl/web/ncbr/konkurs-11112021bezpieczka-sciezka
- The project can be implemented until 31 December 2023.

The application should be accompanied by attachments in the form of a scan of a hand-signed document or a document bearing a qualified electronic signature.
