COMMUNICATION BY THE JAGIELLONIAN UNIVERSITY VICE-RECTOR FOR RESEARCH of 19 July 2021

on: submitting funding proposals under the 'Science for Society' programme announced by the Minister of Education and Science

This is to inform you that a communication by the Minister of Education and Science of 1 July 2021 on launching the programme 'Science for Society' and a call for proposals has been published on the websites of the Ministry of Education and Science (MEiN).

The new programme by the Minister of Education and Science seeks to support the entities representing the system of higher education and science and other organisational entities active in science dissemination in implementing projects intended to build cooperation between entities active in the domain of science and entities active in the social and economic sphere.

The programme provides for funding projects in three areas:

- Scientific excellence;
- Science for innovation;
- Humanities Society Identity.

The call for proposals at the MEiN is continuous:

Basic information on the projects:

- The maximum implementation timeframe is 24 months;
- The minimum and maximum costs of project implementation are, respectively, PLN 100,000 and PLN 2.000.000:
- Indirect costs may not exceed 15% of the awarded funding.

JU internal regulations:

In view of the fact that under the call a university may submit no more than 4 proposals in a given calendar year, each faculty / entity may present only 1 proposal.

Please send in appropriate declarations, drawn up following the template attached as Annex 1 to this Communication, **by 9 August 2021**:

- A JU entity shall submit with the call assistant at the CAWP one proposal selected by the JU organisational entity head (dean for faculties, or director / head of other organisational entity);
- A JUMC entity shall submit with the Division of Domestic Programmes at the Research Department
 of the JUMC one proposal selected by the JU organisational entity head (dean for faculties, or
 director / head of other organisational entity);

Proposed projects may be submitted electronically (a document signed with the qualified electronic signature by the prospective principal investigator and JU or JUMC organisational entity head (dean – for faculties, or director / head of other organisational entity) or as scans of signed proposals.

Based on the declarations sent by you, JU authorities will decide on the selection of the proposed projects and further mode of proposal proceedings. The call assistant at the CAWP or the Research Department at JUMC shall inform you of the decision of JU authorities.

In the event that the JU or JUMC entity fails to submit the declaration of participation in the programme by the above mentioned deadline or that JU authorities fail to select the proposed projects, a new deadline shall be set for submitting declarations under the programme 'Science for Society.'

Once the information on the proposals selected for further processing has been communicated:

1. concerns JU entities

The call assistant at the CAWP will contact the representative of the host entity of the selected project to determine individual dates for delivery of project documentation (i.e. a research project entry form and a VAT eliqibility form, and a draft and the final version of the proposal).

A research project entry form and a VAT eligibility form are to be filled out in the electronic system JU Project Zone at: https://strefaprojektow.uj.edu.pl/.

2. <u>concerns JUMC entities</u>

A call assistant at the Research Department will contact the representative of the host entity of the selected project to determine individual dates for delivery of project documentation.
