VICE-RECTOR FOR RESEARCH
of 5 November 2021**

on: submitting proposals in a Polish National Agency for Academic Exchange (NAWA) programme: "Strategic Partnership".

This is to inform you that the Polish National Agency for Academic Exchange (NAWA) has announced a call for proposals under the programme: **Strategic Partnership**.

The main objective of the programme is to support institutions of higher education and science in developing enduring solutions in teaching, research and commercialization collaboration carried out as strategic international partnerships.

Project results should constitute a base for development of long-term cooperation between the entities forming the partnership. Projects implemented under the programme must fall within long-term development policy of the applying entity.

Under the call, **one University may submit up to 3 proposals**.

The call for proposals at the NAWA is open until 13 January 2022, 3:00 p.m.

Terms and conditions of applying in the call are available on the websites:

Call essentials:

- It may be carried out between 1 July 2022 and 30 June 2023.
- A project may be implemented over a period from 12 to 24 months
- The maximum amount of funding allocated for the implementation of an individual project is PLN 2,000,000.
- The project follows a partnership formula, featuring at least one strategic partner.
- The following actions may be implemented under the project:
 - holding exchanges/lectures/study visits/corporate internships of students, doctoral students and staff of the institution – at the registered offices of the partners or entrepreneurs, including granting the persons involved in the research and R&D work access to the entrepreneurs/partners' R&D centres;
 - development or designing of new educational tools and methods by applicants and partners;
 - development of modern educational materials, to be used by applicants and partners;
 - building and operating high-quality study programmes offering on graduation a joint or double diploma.
 - joint international R&D work by applicants and partners (cooperation with businesses may not be for-profit activity) and presentation and publication of its results;
 - development of a strategy for dissemination of research results by applicants and partners;

- development of a system of quality management at partner institutions within the scope of upgrading education quality;
- initiating cooperation with foreign entrepreneurs aimed at adapting the applicant's education offer to market needs.

Internal regulations:

In view of the fact that **one university may submit up to 3 proposals**, please submit declarations of application as per the specimen attached as Annex 1 to this communication by **25 November 2021 at the latest. Please make the selection and send in one proposal per entity.**

Draft proposals may be submitted:

- electronically (documents signed with a qualified electronic signature);
- in the form of a scan of the signed declaration alongside with a version of the proposal open to editing.

Submission of draft proposals:

- a JU entity shall submit with the call assistant at the CAWP one proposal selected by the JU organisational entity head (dean, director / head of other organisational entity);
- a JUMC entity shall submit with the call assistant at the Research Department of the JUMC one proposal selected by the JU organisational entity head (dean, director / head of other organisational entity).

Based on the declarations you will have submitted, Jagiellonian University authorities will decide on the mode of further processing of the proposals. A call assistant at the CAWP or the Research Department at JUMC shall inform you of the decision of JU authorities.

Once the information on the proposals selected for further processing has been communicated:

- concerns JU entities:

The call assistant at the CAWP will contact the representative of the host entity of the selected project (author of the proposal) to determine individual dates for delivery of project documentation (i.e. an education project entry form and a VAT eligibility form, and a draft and the final version of the proposal).


- concerns JUMC entities

The call assistant at the Research Department will contact the representative of the host entity of the selected project (author of the proposal) to determine individual dates for delivery of project documentation (i.e. a research project entry form, a VAT eligibility form, project statistical data, and a draft and the final versions of the proposal).
