**on: submitting project funding proposals under the PROMOTION OF THE POLISH LANGUAGE (no 21/2022) call published by the National Agency of Academic Exchange.**

This is to inform you that the Polish National Agency for Academic Exchange (NAWA) has opened call for proposals under the *Promotion of the Polish Language*.

The objective of the call is to promote Polish language together with the elements of Polish history and culture through the funding of ventures which enhance teaching quality and prestige of Polish as a foreign language.

The projects shall be creative and provide high degree of adaptation to the needs of target groups. Preference is given to actions addressed to a foreign recipient, which are to be carried out jointly with a foreign university, and which have not been taken so far by the applicant in the scope and scale proposed in a project.

The call for proposals at the NAWA is open until 01 August 2022.

**Basic information on the projects:**

- Funding will be granted to the actions carried out in Poland or abroad, which serve to disseminate Polish as a foreign language and enhance its teaching.
- The project may be carried out in the period between 1 October 2022 and 31 December 2023 and may last from 3 to 12 months.
- The maximum funding per project is PLN 100,000.
- The announcement of the call's results shall be issued by 30 September 2022.

**JU internal regulations:**

In view of the fact that **one university may submit up to 3 proposals concerning three different projects**, please submit **by 20 June 2022 declarations of application** as per the template attached as Annex 1 to this Communication.

I recommend that each Faculty/Entity select only 1 proposal. Nevertheless, should a JU entity wish to submit more call entry declarations, the Head of the JU organisational entity shall subject them to preliminary verification and present them in the form of a list ordered by recommendation strength, sent alongside the declarations to a call assistant at the RSC.

Project proposals signed by the Author and the Head of the organisational entity (i.e. dean, director/head of other organisational entity) may be submitted electronically (a document signed with a qualified electronic signature or in the form of a scan with a handwritten signature alongside a version of the proposal open to editing).

Based on the declarations sent by you, JU authorities will decide on the selection of the proposed projects and further mode of proposal proceedings. The call assistant at the RSC shall inform you of the decision of JU authorities.

Pursuant to the Ordinance no 56 of JU Rector of 11 July 2016 on: *The procedure for drawing up and implementing projects funded from external sources at Jagiellonian University* authors of the projects are asked to deliver to the RSC:

- **by 21 July 2022:**
  - **a draft proposal**, for the purposes of review and verification of formal and accounting eligibility (electronic version of the proposal in the form of a pdf file sent to the address of the call assistant at the RSC);
  - **an education project entry form and a VAT eligibility form** filled out in the electronic system JU Project Zone at: <https://cwn.uj.edu.pl/strefa-projektow>;
- **by 27 July 2022 the final version of the proposal** (electronic version sent in as a pdf file signed with a qualified electronic signature or a hard copy signed with handwritten signatures) – signatures required: project author and the head of the JU organisational entity (i.e. Dean or Director/Head of other organisational entity) acting as the project's host institution.
