Information by the Research Support Centre of 23 January 2024

on: submitting project funding proposals under the VI Polish-Turkish call announced by the National Centre for Research and Development.

This is to inform you that the National Centre for Research and Development (NCBR) has announced a call for proposals in the VI Polish-Turkish call.

The call is aimed at research organisations and innovative companies from Poland and Turkey. Consortia made up of Polish and Turkish partners have the opportunity to obtain funding for projects involving industrial research and development work in selected areas indicated below:

- Health: Pharmaceuticals, Biomaterials, Medical Diagnostic Kits;
- Advanced Material Technologies: Biomaterials, Polymers, and Plastics;
- Food and Agriculture: Food Processing and Production Technologies, Food Biotechnology;
- Energy: Energy Storage, Renewable Energy (including hydrogen energy, solar energy, and biomass).

The research carried out should be between Level 4 and Level 8 of technology readiness (TRL).

The call for proposals at the NCBiR is open by 04 March 2024.

Basic information on the projects:

- The maximum duration of projects cannot exceed 36 months.
- The maximum project grant is PLN 850,000 (exchange rate for conversion: 1 EUR = 4.3413 PLN).
- A Polish consortium can have a maximum of three members, including at least one company.
- The condition for application is the conclusion of a Polish and international consortium agreement.
- Indirect costs account for 25% and are charged to the categories Remuneration and Other Direct Costs. Indirect costs may not represent more than 20% of the total eligible costs of the project.

Proposal submission at the NCBR:

The proposoal along with the required attachments (scans of signed documents or documents signed with a qualified electronic signature) shall be sent by the Principle Investigator via e-mail to: konkursturcja@ncbr.gov.pl by 4 March 2024.

JU internal regulations:

In the case of projects submitted as part of a consortium, due to the provisions of the call documents concerning joint and several liability of the partners for the implementation of the projects, the consent of JU Authorities to apply in the competition will be taken individually on the basis of the submitted declaration.

Preliminary declarations of participation in the call, prepared in accordance with the template constituting Annex 1 to this Information of the RSC, should be submitted immediately, but no later than by 2 February 2024, to the e-mail address of the call assistant at the RSC (not applicable to the JU MC).



In the case of participation in a project consortium of a private entity in the context of joint and several liability of the project partners, Jagiellonian University reserves the right to examine the financial condition of a given private entity.

Project proposals signed by the Author and the Head of the organisational unit (i.e. Dean, Director/Head of other organisational unit) to act as a host entity, may be submitted electronically (a document signed with a qualified electronic signature) or in the form of a scan with a handwritten signature alongside a version of the proposal open to editing.

Based on the declarations you will have submitted, the Jagiellonian University authorities will decide on the approval for your further proceeding with the Centrum Wsparcia Nauki application in the call. The call assistant at the RSC shall inform you of the decision of the JU authorities.

Once the information on the proposals selected for further proceedings has been communicated, the call assistant at the RSC will contact the unit representative of the selected project in order to establish individual deadlines for the submission of project documents (i.e. Consortium Agreement, Research Project Entry Form, VAT Eligibility Form, as well as draft and final versions of the proposal).

The Research/Other Project Entry Form and the VAT Eligibility Form should be filled out in the electronic system JU Project Zone https://strefaproiektow.ui.edu.pl/.

The proposal may be electronically submitted in the system only once the approval by the JU authorities have been secured. The proposal, signed by JU authorities will be sent to you to email addresses you have named by the call assistant at the RSC.
